### **General Activities**

1. Appointed as the Prosecutor General of Korea, on the 16th of August
  - With support and encouraging messages from ExCom members, will be an opportunity to reinforce IAP activities and contribution by the Prosecution Service of Korea
2. Proposed the "Asia-Pacific Convention for Cooperation in Criminal Justice"
  - Preparing an overall action plan and a Convention draft as well as an ExCom proposal

### **Promotion and Member Recruitment**

#### 1. Promotion through meeting with major personnel

Met the Minister of Justice of Japan

- Had discussion on the next IAP Regional Conference, with emphasis on more active participation in the IAP
- Shared common recognition on the necessity of a regional cooperative network to enhance collaboration within the region

B. Met UNODC Regional Representative of the East Asia and Pacific

- Discussed on the feasibility and future plans for closer network and cooperative platform among Asian prosecution services

C. Sent Korean prosecutors to India

- Fortifying contact points and urged for expanded membership to, and increased participation in, the IAP

#### 2. Promotion through Conferences initiated by Korean Prosecution Service

- Hosted the ADLOMICO (Anti-Drug Liaison Officer Meeting for International Cooperation) Conference

- Over 176 prosecutors and experts from 23 countries participated with intentions on intensifying cooperation against drug crime, and special emphasis was added on the cooperation through the IAP network

1. Participation in the Cameroon ExCom

- Gave opinion on various issues including the invigoration of the IAP General Meeting
- Promotion activities and soliciting support for the 6th IAP Asia-Pacific Regional Conference in Dubai

2. Participation in the World Summit of Prosecutors General, Attorneys General, and Chief Prosecutors, in Romania

- Looked into the possibility of co-hosting the World Summit with the IAP Annual Conference

3. Supported the 14th IAP Annual Conference in Ukraine

- Dispatched large-scale Korean Delegation to the Conference as Prosecutor General of Korea
- Arranged for a presentation by UNODC on the cooperation among the criminal justice systems of Asia, to be pursued in the region
