

<u>Call for applications for the Summer School on 'Understanding and Combatting</u> Corruption - A Global Perspective'

The Siracusa International Institute for Criminal Justice and Human Rights will organize a **Summer School on 'Understanding and Combatting Corruption - A Global Perspective'**, between Monday, July 18th and Friday, July 22nd. The Summer School will take place in presence at the headquarters of the Siracusa Institute, located **in Siracusa**, **Italy**.

The Summer School will consist of **6 daily sessions** spread over 5 days, for a total of 20 academic contact hours. The daily sessions will consist of a **combination of presentations from experts and participants** on the reading material which will be provided in advance to the Summer School; they will be programmed approximately between h. 9.30 and 13.30, CET. The afternoons will be dedicated to **study groups**, **self-study and social activities**; they will be programmed approximately between h. 14.30 and 17.30, CET.

Participants who attend successfully the Summer School will receive the **Certificate of Specialization of the Siracusa International Institute**.
